Picturesque Newport Country Club was incorporated in 1922 as a nine-hole golf course. Construction in 1971 reconfigured the original layout and added nine holes. The current 18-hole course continues to be improved according to a master plan formulated with help from Graham Cooke. An updated clubhouse with a dining facility, pub, golf shop, and locker rooms were built in 1994. The course is situated on a high plain overlooking the community of Newport and beautiful Lake Memphremagog with views of the Green Mountains, Jay Peak to the west and Willoughby gap to the southeast. It is situated in Orleans County which is one of three counties collectively referred to as the Northeast Kingdom of Vermont - a rural area recognized by National Geographic as one of the "special" areas of the country.

Named Orleans County's Best Golf Course, Site of 2019 Ladies New England Mid-Am Invitational, chosen to host the 2020 Sr New England Mid-Am, Nestled in the quintessential hills of Vermont's Northeast Kingdom only 30 minutes from some of Vermont's finest skiing.
